All new student admissions to Oregon Islamic Academy are **probationary** over the course of a determined period spanning a few months from the date of enrollment. The Period of probation is determined by OIA Office Staff, and ranges from one trimester to one full academic year. The student's behavior and academic record will be reviewed at the end of the probationary period to determine continued enrollment at OIA.

### **Academic probation:**

Students under academic probation are expected to earn a minimum of a "B" grade (or an overall GPA of 3.0) in all Core subjects (Reading/Writing, Math, Science, Social Studies, Islamic Studies, and Arabic).

During the academic probation period, the student's overall attitude and performance in class with regard to homework, class work, quizzes, and tests, will be closely monitored and recorded on a regular basis.

Ongoing communication between the teachers and the parents of the child under probation will inform parents about their child's academic progress and status, and will alert parents about areas of needed improvement.

### **Behavioral probation:**

The image a school is often determined by the behavior of its students and the physical appearance of the building. We expect all students to show pride in their school by doing their share to make Oregon Islamic Academy (OIA) a better place to learn and work. An OIA student is expected to display excellent citizenship and Islamic character at all times. A good citizen is involved in his/her community by actively working to make his/her learning community a better place. A good citizen abstains from any conduct or behavior that hurts or disturbs others in his/her learning community. A student who displays excellent Islamic character is a benefit to all those around him/her.

All new students will be placed on behavioral probation and expected to abide by and follow the code of conduct guidelines (attached) and listed in the OIA parent handbook at all times.

During the probationary period, a student's behavior and overall attitude will be closely monitored and recorded on a regular basis. Any behavioral which proves to be detrimental to the staff and/or students, will result in immediate termination of enrollment at OIA.

***A violation of any rule by new students during the probationary period may result in discipline and/or immediate dismissal and expulsion from OIA.***

***By signing this contract, I agree that I, \_\_\_\_\_, will abide by all OIA rules and regulations at all times. I understand that in case I did not pass the academic and/or behavioral probation, I will be dismissed from Oregon Islamic Academy. I also understand that violation of any OIA rules or regulations during my probation period may result in my immediate dismissal from OIA at the discretion of OIA staff and the MET Office.***
